ARTICLE 1 – GENERAL NOTICE

1.01 The **Laguna Madre Water District** (Owner) is requesting Bids for the construction of the following Project:

This contract is to be funded through a loan obtained from the Texas Water Development Board as part of the Drinking Water State Revolving Fund. There are a number of special provisions for this funding that bidders, by submitting a bid, acknowledge understanding, including the following: A contract is contingent upon release of funds from the TWDB. Any contract or contracts awarded under this Notice to Bidders are expected to be funded in part by financial assistance from the TWDB. Neither the State of Texas nor any of its departments, agencies, or employees are or will be a party to this Invitation for Bids or any resulting contract.

Equal Opportunity in Employment - All qualified applicants will receive consideration for employment without regard to race, color, national origin, sex, religion, age, or handicap. The contractor shall carry out applicable requirements of 40 CFR Part 33 in the award and administration of contracts awarded under TWDB financial assistance agreements. Failure by the contractor to carry out these requirements is a material breach, which may result in the termination of the awarded financial assistance.

- 1.02 Description of the Work
 - A. The scope of the project includes the installation of a new Raw Water Transfer Pump Station at Water Plant 2/Reservoir No. 3 (located adjacent to Water Plant 2) including, but not limited to, the following:
 - 1. Site improvements
 - 2. New raw water transfer structure and intake pumps
 - Demolition of existing pump station discharge piping, valves, and appurtenances
 - 4. Yard piping and associated valves, structures, and appurtenances
 - 5. Associated electrical, instrumentation, and Supervisory Control and Data Acquisition (SCADA) improvements
- 1.03 The Project is to be substantially complete and ready for operation on or before 300 days after the Notice to Proceed. The Project is to be complete and eligible for final payment 30 days after the date for Substantial Completion.

- 5.01 Questions are to be submitted using the question and answer process on the procurement website. A response will be posted for questions received no later than **5:00 pm** on **Friday, November 29, 2024**.
- 5.02 A response to a question posted on the procurement website that requires modification of the Contract Documents will be made by Addenda. Modifications to the Contract Documents prior to the award of the Contract can only be made by Addenda. Only answers in Addenda posted on the procurement website will be binding. Oral and other interpretations or clarifications will be without legal effect.

ARTICLE 6 - BID SECURITY

6.01 Offerors must submit an acceptable Bid Security with their Bids as a guarantee that the Successful Offeror will enter into a contract for the Project with the Owner within 15 days of Notice of Award of the Contract. The Bid Security must be payable to Laguna Madre Water District in the amount of 5 percent of the proposed Contract Price. The Successful Offeror must

- 6.02 Bid Security may be in the form of a bid bond, a cashier's check, or certified check. Checks must be made out to Laguna Madre Water District. The bid bond may be submitted on the form provided in Section 00 43 13 "Bid Bond" or Offerors may provide their surety's standard penal sum bid bond form. The bid bond must reference the Owner and Project by name as identified in this Section.

- 9.02 Performance and payment bonds will be required for this Project.
- 9.03 Owner reserves the right to reject any and all bids.
